




# Minutes from the Forty-Fourth Annual Meeting of the <u>Tri County Southern Baptist Association</u>

September 29, 2019 at First Baptist Church Ozark Theme: "One Body, One Family, One Mission"

#### **MINUTES FROM THE BUSINESS SESSION:**

Rev. Bob Long (Billings FBC), TCBA president, called the meeting to order at 4:00 pm.

Rev. Josh Hall (Selmore Baptist Church) led in prayer.

Mrs. Iva Hodson (Crane FBC), TCBA clerk, presented a motion to seat the 83 messengers present. Seconded and carried without dissent.

Mrs. Hodson presented a motion to approve the agenda for the business session. Seconded and carried without dissent.

Mrs. Hodson presented a motion to accept the 2018 Minutes from the 2018 Annual Meeting as printed. Seconded and carried without dissent

Dr. Richard Eakins (Chadwick FBC), TCBA Vice-President, read the Resolution of Appreciation

Rev. Long presented a motion to approve 2020 TCBA Leadership as printed. Seconded and carried without dissent.

Mr. William Brandt, CPA (Union Ridge Baptist Church), gave a report of the financial review he conducted of the association's finances.

Rev. Long presented a motion from the Administrative Team to approve the 2020 TCBA Financial Plan as printed. Seconded and carried without dissent.

Dr. Phillip Shuford (FBC Ozark), TCBA Director of Missions, gave the Director of Missions report as printed in the Book of Reports.

# Something's Happening

Director of Mission's Report to the Tri-County Baptist Association of Churches

Behold, I am doing a new thing; now it springs forth, do you not perceive it?

Isaiah 43:19

No one would have predicted the tremendous changes and challenges the COVID-19 pandemic has brought to the world, our nation... and our churches.

Consider it: in the Spring of 2020, ceased holding public worship services Something completely unexpected and

almost every church in our fellowship and activities. Incredible. Unheard of. for which we were totally unprepared.

me to the conviction that, no matter that conviction in turn leads me to the crisis,

#### Something's happening.

I want to report to you that I have been amazed and encouraged by how the churches of Tri-County Baptist Association have confronted the trials of the past few months. You've found ways to worship—either on-line or in smaller gatherings. You'd found ways to connect with each other. You've been faithful in your giving to Kingdom causes.

And somehow in all this, God is working. More than one pastor has told me that in these days of global crisis, because the whole coronavirus thing forced them to go on-line with their worship services, their church now has a wider impact and reaches more people than ever before.

We've always said: "The church is the people, not the building." In 2020 we learned to live that out.

#### Something's happening.

Our gatherings have taken place in church front yards and in parking lots. Our pastors' sermons have boomed into busy intersections, been transmitted across FM radio frequencies and echoed across hills and hollows. We've gathered around TV screens and computer monitors to hear the familiar and comforting voices of our shepherds who, in spite of all the changes, continued to faithfully proclaim God's word. Maybe it wasn't our plan to do so (and maybe we didn't have a chance to vote on it!), but we've taken "the Church" outside the four walls of the church.

Something's happening.

As I write this, at the close of the ninth month of 2020, some Tri-County churches are back to their normal schedule, but others still meet outside for worship or on-line. But even for those churches that are mostly "back to normal" I suspect that the old adage "We've never done it that way before" has forever been thrown out the window (and good riddance!)

True, it's not been easy, and many ways it's still not easy. There are a number of COVID-19 challenges facing our churches. But something's happening.

Through the prophet Isaiah, God spoke these words: "Behold, I am doing a new thing; now it springs forth, do you not perceive it?" (Isaiah 43:19)

Churches, let's let God do a new thing—and not be so quick to rush back to "the way it used to be." Let's never forget the prime lesson of the coronavirus age:

that our Lord's Church has never been a building,

"church" is not a place,

"church" isn't the time a group of people get together to hold a worship service, but that the Church is God's people, taking the Good News of hope and new life in Jesus to our neighbors and our communities that are soaked in discord and despair.

In my view, it's not your association's job to make disciples. Your association exists to come alongside our member churches to help them make disciples.

And I want you to know how the Lord has been working in our association during the COVID-19 crisis.

As many of you know, in October of last year Tri-County sold to the College of the Ozarks our property located just off the college's campus, for \$600,000. Last November Tri-County's Executive Board voted to allocate the proceeds of the property sale in ways that will enhance the association's ability to fulfill our mission of "encouraging, assisting and resourcing our churches to fulfill the Great Commission." Accordingly, here's how the funds received from the sale are being used:

We sent a tithe of the proceeds of the sale (representing \$60,000) to four missions and ministry efforts: \$15,000 each to the International Mission Board, the North American Mission Board, the Missouri Missions Offering, and Baptist Hill Assembly.

We've invested the remainder of the proceeds in interest-bearing funds held by the Missouri Baptist Foundation.

- We established a Great Commission account (\$240,000) that is being used to help our churches do ministry above and beyond what they may be able to do on their own.
- We set up a Baptist Student Union account (\$100,000), to ensure that the BSU's ministry at the College of the Ozarks will be viable and vital for years to come.
- We set up an operating reserve/building maintenance account (\$100,000) that will help us be good stewards of Tri-County's office building and other assets.
- We invested \$100,000 in the Jim and Judy Wells Ministry Scholarship Endowment, that will
  provide tuition assistance for Tri-County church members who are studying for the ministry,
  starting in 2021.

When the COVID-19 crisis hit, it became clear that Tri-County's "what" (encourage, assist and resource churches to fulfill the Great Commission) had not changed. But the "how" Tri-County does that changed drastically. Many of the things Tri-County is known for (summer camps and Vacation Bible School training, to name a couple) became impossible to do.

So, when churches stopped meeting for public worship, rather than just sit on our hands, your association's staff actively sought out ways to assist our churches and pastors deal with the sudden changes thrust upon them. We did this in three ways:

- **Prayer and encouragement.** We prayed with kept in contact with pastors and church leaders, reminding them that they were not alone and that God was in control;
- **Information.** We provided up-to-date information so that churches would know what to do and what to expect as the crisis developed;
- Practical assistance, such as: In partnership with the Missouri Baptist Convention, we
  provided funds to each Tri-County church to use during the crisis in any way they needed; we
  helped churches develop an on-line presence; we provided resources for churches to adapt
  and do Vacation Bible School and other outreach-oriented activities.

Dear friends, make no mistake—something is happening, and God is at work. And He Who declares "Behold, I make all things new!" (Revelation 21:5) is doing things beyond our capacity to comprehend. We don't have to understand what He's doing. We just have to trust and go forward, following Him Who knows how to walk on the stormy sea.

In 1773, the English hymn writer William Cowper penned these lines, very appropriate for 2020: God moves in a mysterious way, His wonders to perform; He plants his footsteps in the sea, And rides upon the storm.

Friends, let's ride the storm with Him, and He will see us to the other side!

Thank you for the privilege of serving the churches of Tri-County Baptist Association.

- Ministered to and strengthened pastors and staff members from our churches by providing for them opportunities for fellowship and mutual prayer.


#### **Pastor Search Assistance**

### **TCBA's Summer Camps**

TCBA's Summer Camp ministry assists our churches with their evangelistic and discipleship efforts with children and young people.

Tri-County's Summer Camps in 2020 became a casualty of the COVID-19 pandemic, which beginning in March forced shut-downs and lock downs all across the nation. Because our camps were scheduled for the first week of June, and the "ramp up" for camp normally takes place in April and May, we had to make a decision by mid-April whether or not to modify or cancel camp. In light of the safety and health of our churches' children, youth and adult volunteers and given the uncertain future of the shut-down, we made the very painful and very disappointing decision that canceling camp was the best thing to do. It is little consolation to know that many Baptist association camps across Missouri did the same.

Immediately upon deciding to cancel camp we began planning an alternative one-day event for August 8, "Soul on Fire" to be held at First Baptist Church of Ozark. Our assumption at that time (in mid-April) that churches and communities would be re-opened by then. As the summer progressed and many churches either remained closed or greatly reduced their schedules, it seemed best to not proceed with that event either.

So, now we're looking forward to next year, and using ideas from both our camp plans and Soul on Fire to make Tri-County's 2021 Summer Camps the most amazing ever!

#### **Vacation Bible School**

Vicky Perkins (FBC Nixa), Director

Tri-County's VBS Ministry trains leaders and provides resources for our churches to hold evangelistic Vacation Bible Schools.

Tri-County's VBS ministry emphasizes training new and existing church leaders, and providing resources that help our churches do VBS. We primarily work with LifeWay VBS materials but are able to support any of our churches' choice of curriculum.

The 2020 LifeWay VBS theme was "Concrete and Cranes: Building on the Love of Jesus." Unfortunately, the COVID-19 pandemic took a wrecking ball to most Tri-County churches VBS plans. The concern for not spreading the virus led many of our churches to cancel their VBS altogether. But 13 Tri-County churches reported having VBS this year—with a total attendance of 1,502! Some churches adjusted their VBS plans to fit the "new normal." It's amazing to see how our churches used their God-given creativity to reach children and youth through VBS in spite of the COVID-19 crisis, whether through virtual VBS, one-day or weekend VBS, or using the VBS materials for children's church or Wednesday night children's activities.

As our churches adjusted and adapted, so did we! Here's how your association assisted our churches to make this year's VBS a total (if unusual!) success:

- Training and Information: VBS Pre-Clinic and Leaders' Overview on February 10 with 14 churches represented. Our main training workshop, scheduled for April 27, was cancelled due to the COVID-19 shut-down. We were active in working with our churches providing ideas for alternative ways they could do VBS. One Tri-County church we helped train had not had VBS in 10 years, and they faced the coronavirus challenge with wonderful creativity.
- Resourcing churches: Tri-County provided VBS materials and decorations several churches used. We provided ministry funds to one rural church to assist them with their VBS—and 2 children got saved!

That's what VBS is about—kids coming to Christ, and our churches growing in Christ-likeness.

# **Tri County Bible Institute (Seminary Extension)**

Dr. Richard Eakins (FBC Chadwick), Lead Instructor

TCBA's Tri-County Bible Institute's provides accredited and academically challenging theological and ministry training to prepare the called to serve in TCBA churches and beyond.

God is calling people out of our Tri-County churches to serve Him, and the Tri-County Bible Institute has been helping train them for ministry for over a decade.

The COVID-19 crisis interrupted our Spring classes, but our students and instructors came back together and successfully completed their coursework. Normally we teach only one class per semester, but this year we have been able to teach two.

# Ozarks BSU—College of the Ozarks

The Ozarks BSU goal is to disciple believers at the College of the Ozarks through experiences in worship, leadership development and service.

#### Ozarks BSU—Fall 2020 Update

This past year has been marked by change and unexpected circumstances. At last year's TCBA Annual Meeting we voted to sell the property on which the BSU stood to the college. Soon after, the Rapinchuk family moved off campus and purchased our first home. One month after moving into our home, the college (and most of the nation) shut down due to COVID-19, and we finished the semester online. In August, due to a combination of personal factors and restrictions at the college, Landon asked to pause his role as assistant director for the fall semester and revisit a calling to that position in January.

Despite these changes and challenges, however, the Lord is good. We were able to directly minister to over 300 different students last year, train over 25 in our Leadership in Training Program, preach through a topical series on the Foundations of the Church and an expositional series through the Book of Colossians. We successfully transitioned our worship gathering online in March and finished the semester on Facebook Premiere and Zoom. We then continued online during the summer with a three week series by Kyle Rapinchuk, "Lessons on the Road with Jesus", and an eleven week series on the Book of Philippians from Rusty Osborne, our BSU Faculty Sponsor and a member of the BSU Ministry Board. We also continued weekly discipleship both online and in-person on our porch.

This fall, COVID-19 will continue to interrupt our normal plans. With restrictions on campus making it difficult to have large group gatherings, we are trying to modify our strategy to most effectively accomplish our mission of making disciples who make disciples, love God, and love others. We will host a modified large group gathering called "BSU Food for Thought" in which we deal with the theme of "Christ in Every Aspect of Life." Students will be encouraged to grab the to-go meal option in the cafeteria (hence, "Food" literally!) and join us as we dig into some "meaty" ("food" figuratively!) topics. Christ in our Relationships, Christ in our Politics, Christ in our Education, and Christ in our Identity are several of the topics we will tackle. We will also continue our successful M.O.G. (Man of God) study with the aid of Keno Ayebazibwe, the husband of a C of O Resident Director who is a native of Uganda and has helped (with the aid of Landon and Kyle) develop a five-week study on biblical manhood. His wife, Janalee, hopes to start a women's groups this fall as well. In addition, we hope to start a Tuesday Theology Club, offer a student on our identity in Christ, and continue meeting for one-one-one discipleship with many of our students.

Please pray that the challenges we face will provide opportunities for personal growth and the advancement of the gospel. Pray that our students will re-center their lives on Christ and see His influence in every aspect of our lives. Pray for wisdom and discernment in decision-making, for boldness in proclaiming the gospel, and for strength and endurance to press forward in difficult circumstances. Soli Deo Gloria!

The Scholarship Team makes the determination on which applicant (s) will receive each year's award, and for what amount.

Recipients will be notified no later than June 1.

TCBA will forward the awarded funds to the academic institution on the student's behalf.

Recipients will be recognized at TCBA's Annual Meeting.

#### Application procedure:

Fill out application and submit to Scholarship Team in care of the Director of Missions. Applications are available from TCBA or can be downloaded at www.tcsba.com.

Applications and essays are due no later than March 31<sup>st</sup> of the academic year for which the applicant is requesting support.

#### **Application Instructions:**

1. Complete the application.

The application is a writable PDF. Applicant will be able to save and edit responses if using Adobe Acrobat, otherwise, must print the application after completion. Applicant may also print the application and fill it out by hand. Handwritten applications with illegible handwriting will not be considered.

#### 2. Submit the essay.

The applicant must also submit an essay on the following question/topic: "My Call to Ministry—Past, Present and Future." Submissions may be either a "hard copy" via paper mailed to TCBA's Director of Missions, or submitted electronically to TCBA's Director of Missions with the subject line heading: scholarship essay.

The first positive I would like to share also comes with a huge Thank You to the Tri-County Association. The generous donation that you provided has allowed us to replace the dinosaur dishwasher with a new one and make some needed updates in the kitchen and dish room areas. It is with a humble heart and a prayer of thanksgiving we praise God for this provision that has greatly enhanced what can be done in the food service section of the camp. Thank you for being willing to make this investment in the Baptist Hill ministry.

The second positive that I would like to share has been critical to ministry on The Hill. The economy has definitely been an area of great concern and questions for our country since the COVID-19 virus reached the shores of our country. I am pleased to report that many individuals, churches and associations have been faithful in supporting Baptist Hill even through these tough and concerning economic times. The income from camper fees has taken a major hit but donations have stayed steady. We praise God for His leading in this area and want to share a heartfelt moment of gratitude with those who have continued to support this ministry.

What lies ahead for Baptist Hill? I believe that we must look in two directions to find the answer to this question. First and fore most we must look UP and seek God's guidance and directions as we move forward with this ministry. All of our actions and decisions need to be based on the guidance and directions provided by our Heavenly Father. The next direction must then be to the future and how are we going to accomplish what He has set before us. I want to share 3 major projects or areas of concern that we believe God has pointed us to: roof replacement for the Worship Center; roof replacement for the Dining Hall, and refurbishing of the swimming pool.

We are well aware that all 3 projects require a large amount of resources in order to complete but they are all areas that need immediate attention. Please prayerfully consider what God would have you do as we move forward with these projects. God will provide through each of us doing what we can as individuals, churches and associations.

# Missouri Baptist Children's Home

"Serves God by assisting children, youth and families to make a lasting difference in their lives." Approximately 93% of all ministries were provided in community-based programs rather than on a residential campus. In 2019, MBCH touched the lives of 4,729 children and families. Forty-eight youth were served in therapeutic group homes. One hundred and eighty-five children found loving, forever families. 330 mothers and babies were served through Pregnancy Services provided by MBCH and The LIGHT House. One hundred and forty-seven children were in treatment family care homes and 378 children and youth were in family foster homes. MBCH maintained 303 foster/adoptive and/or relative/kinship homes. Twenty-two young women were served through the "Freedom 43:19" human trafficking rescue ministry. Transitional living programs in Bridgeton, Springfield and Mt. Vernon served 50 young people as they prepared to leave foster care and become independent. Fourteen adults with developmental disabilities received care at Country Haven or The Branches at Brookline. 1,705 individuals were trained in Stewards of Children. There were 17 professions of faith and/or baptisms among the children served in residential programs of MBCH and The LIGHT House or in Treatment Family Homes.
